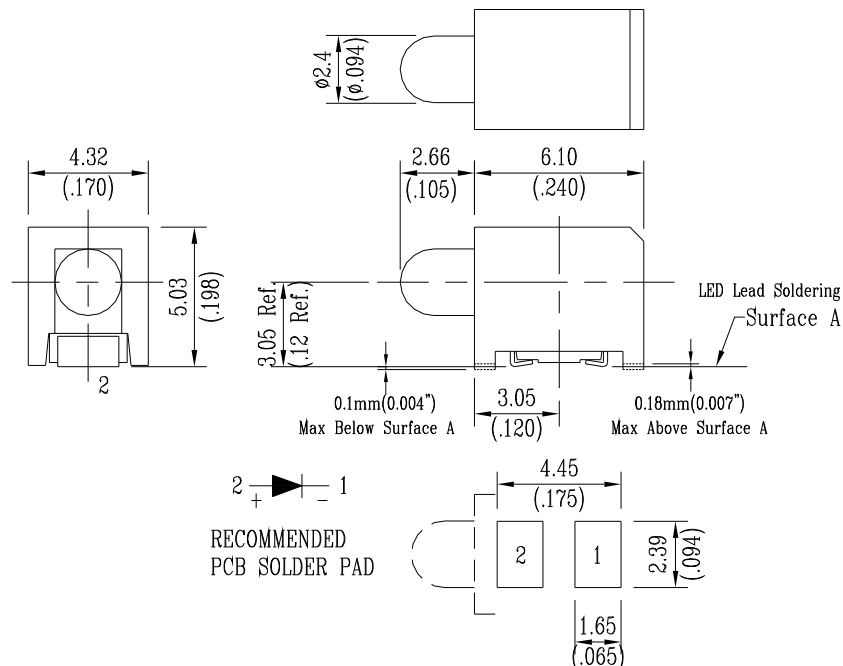

NOTE:

- Luminous intensity is measured with a light sensor and filter combination that approximates the CIE eye-response curve.
- θ 1/2 is the off-axis angle at which the luminous intensity is half the axial luminous intensity.
- Iv classification code is marked on each packing bag.
- The dominant wavelength, λ d is derived from the CIE chromaticity diagram and represents the single wavelength which defines the color of the device.
- Reverse voltage (VR) condition is applied for IR test only. The device is not designed for reverse operation.

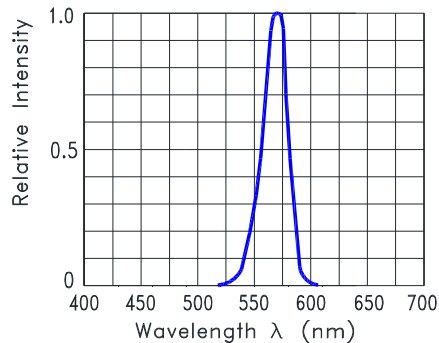


Fig.1 Relative Intensity VS. Wavelength

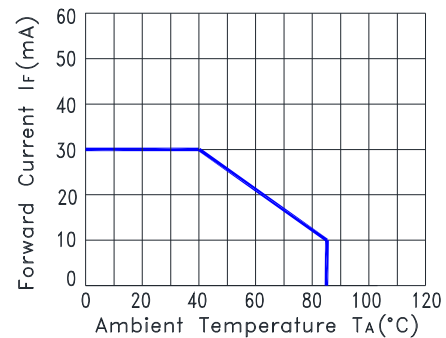


Fig.2 Forward Current Derating Curve

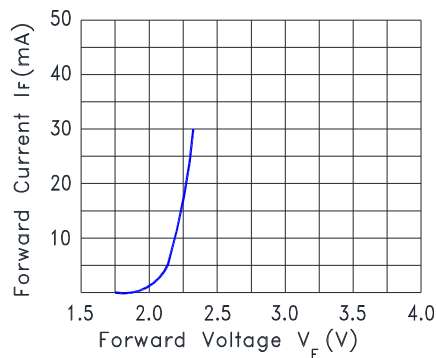


Fig.3 Forward Current vs. Forward Voltage

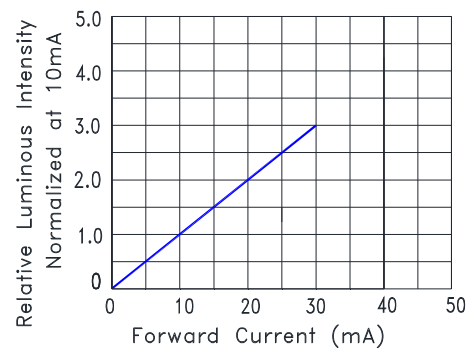


Fig.4 Relative Luminous Intensity vs. Forward Current

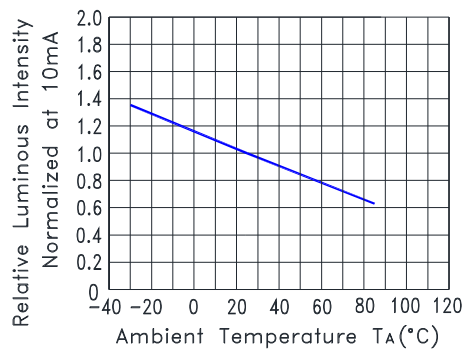


Fig.5 Relative Luminous Intensity VS. Ambient Temperature

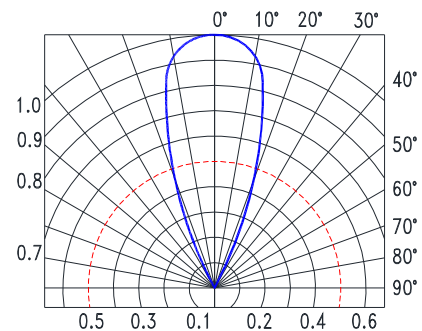
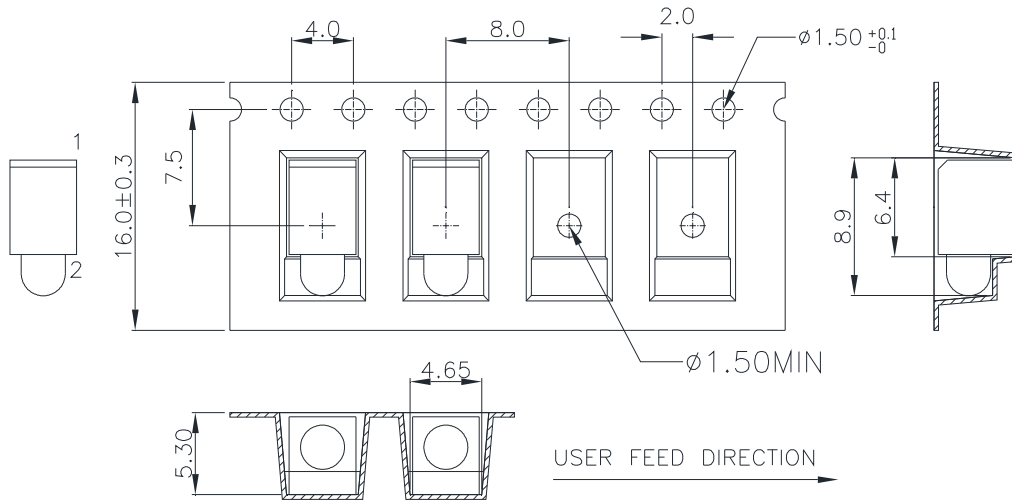


Fig.6 Spatial Distribution

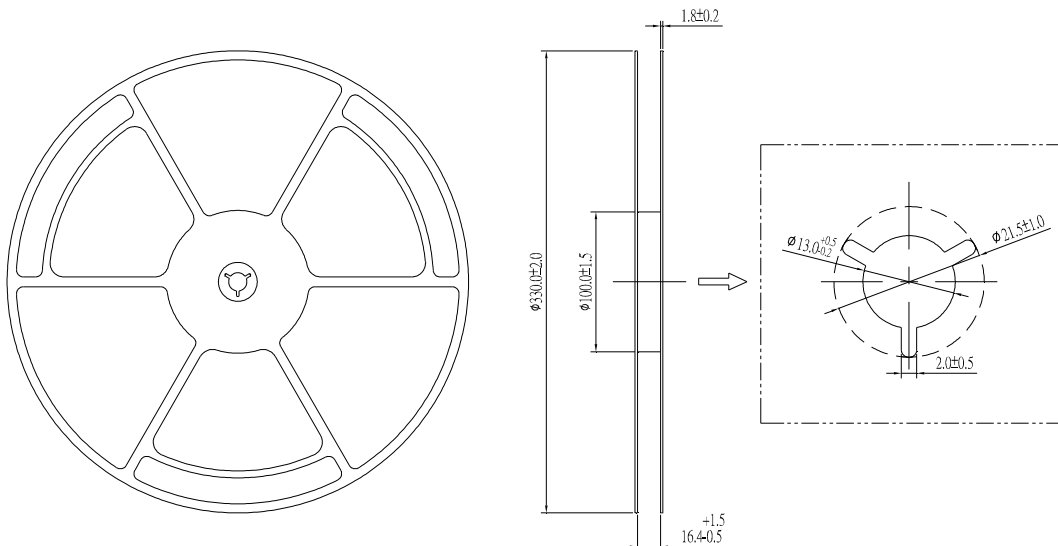

Packing Reel Dimensions



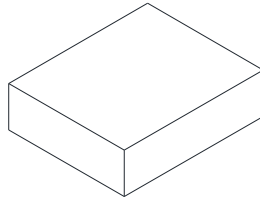

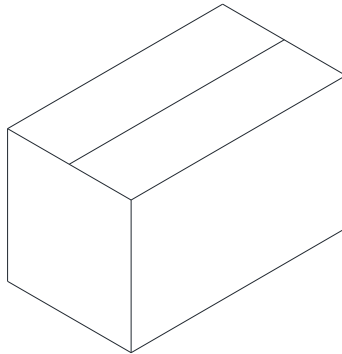

7. CAUTIONS

7.1. Application

The LEDs described here are intended to be used for ordinary electronic equipment (such as office equipment, communication equipment and household applications)

7.2. Storage

The package is sealed:

The LEDs should be stored at 30°C or less and 70%RH or less. And the LEDs are limited to use within one year, while the LEDs is packed in moisture-proof package with the desiccants inside.

The package is opened:

The storage ambient for the LEDs should not exceed 30°C temperature and 60% relative humidity.

It is recommended that LEDs out of their original packaging are IR-reflowed within 168hrs.

For extended storage out of their original packaging, it is recommended that the LEDs be stored in a sealed container with appropriate desiccant, or in a desiccator with nitrogen ambient.

LEDs stored out of their original packaging for more than 168hrs should be baked at about 60 deg C for at least 48 hours before solder assembly.

For unused component, we strongly suggest doing baking following above condition before going SMT assembly process (IR reflow) if the MBB had been opened over 168 hours to prevent MBB from not repacking well or environment moisture over standard required condition which might cause the LEDs function fail.

7.3. Cleaning

Use alcohol-based cleaning solvents such as isopropyl alcohol to clean the LEDs if necessary.

7.4. Soldering

Do not apply any external stress to the lead frame during soldering while the LED is at high temperature.

Recommended soldering conditions:

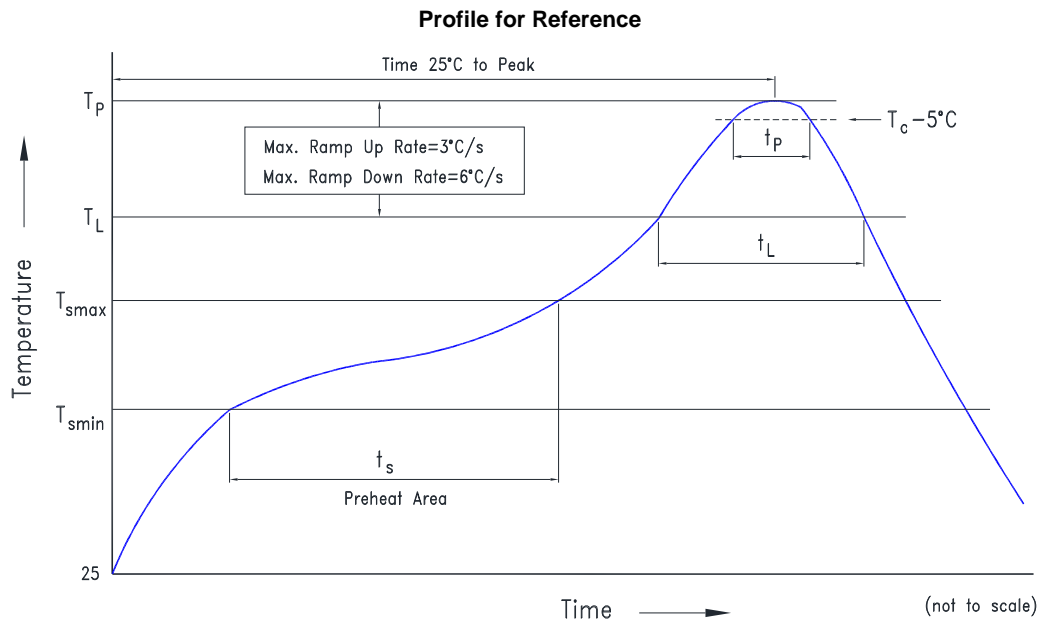

Note:

1. Because different board designs use different number and types of devices, solder pastes, reflow ovens, and circuit boards, no single temperature profile works for all possible combinations. However, you can successfully mount your packages to the PCB by following the proper guidelines and PCB-specific characterization.
2. Figure (next page) shows a sample temperature profile compliant to JEDEC standards. You can use this example as a generic target to set up reflow process.
3. Should adhere to the JEDEC profile limits as well as specifications and recommendations from the solder paste manufacturer to avoid damaging the device and create a reliable solder joint.

Note:

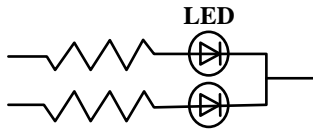
- Excessive soldering temperature and/or time might result in deformation of the LED lens or catastrophic failure of the LED.
- Max temperature of wave soldering or IR Reflow is not means that Holder's HDT/Melting temperature.

7.5. Drive Method

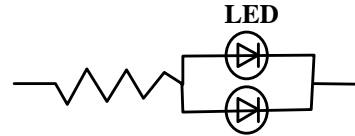
An LED is a current-operated device. To ensure intensity uniformity on multiple LEDs connected in parallel in an application, it is recommended that a current limiting resistor be incorporated in the drive circuit, in series with each LED as shown in Circuit A below.

(B) The brightness of each LED might appear different due to the differences in the I-V characteristics of those LEDs.

7.6. ESD (Electrostatic Discharge)

Static Electricity or power surge will damage the LED.

Suggestions to prevent ESD damage:

- Use a conductive wrist band or anti- electrostatic glove when handling these LEDs
- All devices, equipment, and machinery must be properly grounded
- Work tables, storage racks, etc. should be properly grounded
- Use ion blower to neutralize the static charge which might have built up on surface of the LEDs plastic lens as a result of friction between LEDs during storage and handing

Suggested checking list:

Training and Certification

- 7.6.1.1. Everyone working in a static-safe area is ESD-certified?
- 7.6.1.2. Training records kept and re-certification dates monitored?

Static-Safe Workstation & Work Areas

- 7.6.2.1. Static-safe workstation or work-areas have ESD signs?
- 7.6.2.2. All surfaces and objects at all static-safe workstation and within 1 ft measure less than 100V?
- 7.6.2.3. All ionizer activated, positioned towards the units?
- 7.6.2.4. Each work surface mats grounding is good?

Personnel Grounding

- 7.6.3.1. Every person (including visitors) handling ESD sensitive (ESDS) items wear wrist strap, heel strap or conductive shoes with conductive flooring?
- 7.6.3.1. If conductive footwear used, conductive flooring also present where operator stand or walk?
- 7.6.3.2. Garments, hairs or anything closer than 1 ft to ESD items measure less than 100V*?
- 7.6.3.3. Every wrist strap or heel strap/conductive shoes checked daily and result recorded for all DLs?
- 7.6.3.4. All wrist strap or heel strap checkers calibration up to date?

Note: *50V for Blue LED.

Device Handling

- 7.6.4.1. Every ESDS items identified by EIA-471 labels on item or packaging?
- 7.6.4.2. All ESDS items completely inside properly closed static-shielding containers when not at static-safe workstation?
- 7.6.4.3. No static charge generators (e.g. plastics) inside shielding containers with ESDS items?
- 7.6.4.4. All flexible conductive and dissipative package materials inspected before reuse or recycle?

Others

- 7.6.5.1. Audit result reported to entity ESD control coordinator?
- 7.6.5.2. Corrective action from previous audits completed?
- 7.6.5.3. Are audit records complete and on file?
